### **N.C. Open Government Coalition attends National Freedom of Information Coalition's annual meeting**

Dr. Dale Harrison, Asst. Director of the Sunshine Center, attended the national meeting of open government coalitions in June. The conference was attended by more than 20 of the country's active coalitions and a majority reported higher activity in the past year among citizens seeking government information. Panels featured discussions of how to sustain your open government coalition, how to encourage financial transparency in state government, and 10 technologies open governments should be using to better serve their constituencies. The event closed with a discussion of how to integrate open government into high school civics education. ## Access Update

### **Sunshine bills still making their way through state legislature**

Five bills regarding open government, open meetings and public records continue to make their rounds through the North Carolina State legislature. Here is an update on their status:

- **Keep Recordings of Closed Sessions (House Bill 1263):** Requires large counties and municipalities to tape closed sessions. Referred to Committee on Local Government II. <http://www.elon.edu/docs/e-web/academics/communications/ncopengov/ClosedSessionTaping.pdf>
- **Open Records Attorneys' Fees (House Bill 724):** Awards attorneys fees to prevailing parties in public records disputes. Referred to the Committee on State Government/State Personnel. <http://www.elon.edu/docs/e-web/academics/communications/ncopengov/HB724RecAttyFees.pdf>

- **Open Government/Non-Disclosure Penalties (House Bill 734):** Establishes public records mediation and holds individuals liable in civil proceedings for failure to provide access; awards attorneys fees to successful plaintiffs. - **Increased Transparency of MH/DD/SA Facilities (Senate Bill 799):** Increases disclosure of details about deaths in state facilities and details of facility police and incident reports. - **Open Government Act (House Bill 1134):** Establishes public records mediation and awards attorneys fees to successful plaintiffs. Re-referred to the Committee on Finance. <http://www.elon.edu/docs/e-web/academics/communications/ncopengov/OpenGovtAct09.pdf>

## **NCPA continues fight against changes to public notices**

North Carolina House Republican leader Skip Stam lost a vote in the House Judiciary I Committee to take public notices away from the public. But after the loss, Stam proceeded to move the bill forward for Clayton, N.C., only and won that vote in committee. The bill was approved by the full House in May and is now heading to the Senate for consideration. The North Carolina Press Association said, "We strongly oppose this measure as taking public notices out of even one newspaper where the public will notice means that members of that community (or communities) are denied information that may be vital to them."
