According to current United States Immigration regulations, no student who is a citizen of another country may be admitted to the United States unless he/she presents a Form I-20, *Certificate of Eligibility*, completed by the Designated School Official (DSO) of the institution to which the student has been accepted. Form I-20 lists detailed information, including the estimated cost an academic year, including tuition; source of funds; and amount of funds available to the student.

You are required to certify that you will have available money for your first academic year at Elon University. In computing your financial resources, you should bear in mind that you will not be allowed to seek or undertake employment during your period of study. If you are accepted, it will be necessary to have with you enough funds to cover all expenses for your first year of study when you arrive on campus. The United States Government's Immigration Form I-20 will be mailed to you upon receipt of your enrollment deposit.
