"Learning and Teaching with Technology" is a 2 semester hour course generally taken by many teacher candidates prior to enrolling in methods courses. In the course, candidates gain familiarity with various technology tools and how they can be used in teaching and learning. Candidates explore the idea of digital information literacy and the value of student-created collaborative content as well as investigating tools for facilitating both. They are also exposed to social, legal, ethical issues related to technology use in school settings and are introduced to issues related to equitable access to technology and UDL in terms of electronic texts and how to make them accessible to individuals with various disabilities. This replaces a former course, CIS 220, "Technology in Teaching and Learning" which was required for all teacher licensure candidates. Music education candidates take the course, "Music Education Technology". Secondary math candidates take a 4 semester hour course, "21st Century Technology in Mathematics." Student teachers are provided with staff technology privileges in their field placements. They have access to professional email accounts, are part of school's staff email list, have access to technology resources for instruction – resources normally reserved for teachers. During the student teaching experience, candidates are assessed on technology use as part of their formative observations and evaluations. By including technology as part of the standards/indicators required for evaluation, faculty can ensure that technology is used in the classroom. Student teachers are assessed both through formative and summative methods on their use of technology in the classroom, as it is a required component of their program.

Teacher candidates take coursework that aligns with understanding and applying IEPs and 504 regulations. In their clinical placements, candidates work with students of all abilities. During their student teaching year, candidates work directly with any students with disabilities in their clinical placements.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Student teachers work directly under the supervision of their clinical teachers. Therefore, the student teachers work with students with disabilities in their classroom alongside their clinical teacher. Additionally, the student teachers would be expected to attend any IEP/504 meeting with their clinical teacher.

c. Effectively teach students who are limited English proficient.

Teacher candidates take coursework that includes strategies for working with students who have limited English proficiency (English Language Learners). Another option is for teacher candidates to receive an add-on license in Teaching English to Speakers of other Languages. During their full-time student teaching, candidates work with any ELL students in their classrooms. This is varied based on the placement and student population of the classroom for their full-time student teaching. Teacher candidates might also work with ELL students during one or more of their many clinical placements.

Teacher candidates take extensive coursework and have clinical experiences working with children with exceptionalities. The candidates take coursework that includes laws, methods, assessments and strategies that have correlated clinical experiences.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Teacher candidates work with exceptional children clinical teachers throughout their time in their coursework and during student teaching. During all of these experiences, candidates would have opportunities to review and use IEPs and 504s to plan and execute lessons and assessments, and attend

meetings to create and review IEPs/504s and plan for future goals of these designated students.

c. Effectively teach students who are limited English proficient.

Teacher candidates take coursework that includes strategies for working with students who have limited English proficiency. Another option is for teacher candidates to receive an add-on licensure in Teaching Students with English Proficiency. During their full-time student teaching, candidates work with any ELL students in their classrooms. This is varied based on the placement and student population of the classroom for their full-time student teaching. Teacher candidates might also work with ELL students during one or more of their many clinical placements.
